JOB DESCRIPTION:

The NM Behavioral Health Institute at Las Vegas (NMBHI) is the only state owned and operated psychiatric hospital in New Mexico. NMBHI is made up of five clinical divisions serving a wide range of public needs. Each division is separately licensed and has its own unique admission criteria. The facility provides adult psychiatric services on six units, serving approximately 1000 admissions per year. To ensure optimal environment of quality care, comfort, safety and advocacy for the clients (residents and staff). Interprets, directs implementation and enforces all federal and state guidelines, health care rules, regulations, policies, procedures, and administrative principles for the purposes of licensure and accreditation of facility to include staff development and training. Provides comprehensive administrative services in hospital/facility management. Serves as the facility contact for internal facility governance processes and for inter-agency, intra agency and community planning, coordination, collaboration, policy development and legislation. The position is responsible for a total budget of \$58 Million and an FTE of over 900, in 5 divisions, Forensics, Adult Psych, Long Term Care Nursing Home, Adult and Adolescent Sex Offender Treatment and Out Patient Community Mental Health Center in communities of Las Vegas, Mora, Santa Rosa, and Pecos. The budget is a combination of General Fund, Medicaid, Medicare, private pay and third party reimbursement. Facility is Joint Commission Accredited under three sets of standards (Hospital, Nursing Care, Behavioral Health), and is CMS Certified and Licensed by Children Youth and Families and Division of Health Improvement.
