The North Dakota Department of Health and Human Services (HHS) is seeking a transformative leader for the North Dakota State Hospital (NDSH). In this role you will help to ensure people with severe mental illness and substance use disorders have access to specialized psychiatric and substance abuse services.

The NDSH provides short term acute inpatient psychiatric and substance abuse treatment, intermediate psycho-social rehabilitation services, forensic services, and safety net services for adults, including residents referred by the Department of Corrections & Rehabilitation, and sexually dangerous individuals.

The leadership team of the Hospital operates in a dyad model, and the <u>Superintendent</u> fulfills the administrative and operational needs of the hospital. In this role you will be responsible for the coordination, administration and management of services provided at NDSH. You will oversee the 24/7 operations, the budget and indirectly more than 300 team members providing specialized and residential services. You will direct the mission and philosophy of care incorporating new concepts from the field, while keeping in compliance with regulatory bodies. You also will be the face of the State Hospital in the community and with key stakeholder groups, including the North Dakota Legislature. You will promote and develop positive company culture to create an attitude and environment that cultivates collaboration, productivity, and satisfaction among employees.

To succeed in this position, your experience must include transforming cultures and building highperforming teams in health care settings. In addition, your experience must demonstrate your ability to collaborate effectively with community-based services to achieve better outcomes for individuals served.

DHHS is willing to entertain a variety of qualified professional backgrounds in filling this role. Physician and non-physician candidates will be considered.

Candidates must possess a Bachelor's Degree or Master's Degree in a relevant field <u>and</u> 10 or more years of professional-level experience working in the healthcare field, which includes the following:

- professional training and experience relating to the management of facilities for mentally ill and chemically dependent persons and relating to the needs of the mentally ill and chemically dependent persons
- serving as a healthcare leader/role model who has implemented operational strategy, and effectively enlisted others in change management
- At least 3 years overseeing operations, financial management, regulatory compliance, and financial expertise, as well as implementing process improvements based on data interpretation
- Demonstrated success building a culture of teamwork
- Experience with regulation and accreditation, such as Joint Commission, as well as interpreting federal and state law

The ND State Hospital <u>Superintendent</u> is an appointed position. Qualifications, responsibilities, and scope are detailed in North Dakota's legislation (ND Century Code).

<u>Per the ND Century Code</u> 25-02-04. Superintendent to possess certain qualifications - Medical director - Employees. The superintendent of the state hospital must be a skilled health care administrator with professional training and experience relating to the management of facilities for mentally ill and chemically dependent persons and relating to the needs of the mentally ill and chemically dependent persons.

In accordance with NDCC 25-02-04, if the Superintendent is not a licensed physician and board-certified psychiatrist, the Medical Director, or a qualified designee of the Medical Director, shall act as the Superintendent's designee in all matters in which the Superintendent's opinion on medical or clinical treatment is required by law.
